CONDITIONS OF HIRING

- 1- Only this contract of booking filled with precision is regarded as valid because it provides all the elements making it possible to consider the hiring.
- 2 - The final decision of the acceptance of the hiring depends only on the camp-site.
- 3 - This confirmation is in particular subordinated to the acceptance of the following conditions :
 - a - A fixed price (installment), increased booking's expenses by 15€ , will have addressed being place so that the hiring is definitively recorded. The confirmation of the reception and the hiring is sent at once.
 - b - If the number of people is different with the arrival, or during the stay, among that initially envisaged, the correction of will be carried out.
 - c - If for an unspecified reason, the duration of the stay is curtailed, the total amount of the stay remains acquired with the camp-site.
 - d - The rented sites are placed at the disposal the day envisaged starting from 14h. They will have to be released the day of the departure before 11h.
 - e - All arrived before the date and the hour envisaged exposes the campers to be not able to occupy the site selected.
 - f - The hirings are preserved during 24h according to the date of arrival envisaged. At the end of this period, the site ceases being retained and the versed sum remains sure with the camp-site.
 - g - If you cancel one month before the date of arrival the versed sum is not refunded. If this minimum time is respected, the installment is refunded except the booking's expenses.
 - h - A site is rented by name and will not be able to in no case to be sub-leased.
 - i - In the event of litigation, only the Court of Haut-Rhin is qualified.
